### TITLE:

## Open Data for Social Impact

### SHORT DESCRIPTION:

On May 28, 2025, social economy enabling organisations are invited to join the online workshop **Creating Social Impact Through the Use of Open Data**, a transnational session exploring how open data can support innovation and improved outcomes in the third sector.

Through a combination of expert insights, interactive group work, and thematic discussions, participants will learn how to harness the power of data to identify needs, improve decision-making, and drive innovation in their organisations.

The workshop will feature a mentoring session on open data, a keynote by **Barcelona Open Data**, and a hands-on activity using real datasets. To close, participants will join breakout rooms focused on **health, childhood, and economic activity** to exchange best practices and explore data-driven solutions to social challenges.

The event is led by **Taula del Tercer Sector** and **Clúster Digital de Catalunya** and will bring together actors from the social economy ecosystem across Europe.

The second transnational workshop is part of the programme created within the framework of the DO Impact Strategy, to provide Social Economy Enabling Organisations and SMEs with tools, knowledge, and resources needed to thrive in

today's evolving market. They focus on strengthening digital skills, improving data management, and supporting sustainable practices.

The programme is first delivered to organisations that enable SMEs within the PSE ecosystem and then tailored for local SMEs. The methodology ensures we address specific regional needs and priorities.

**The second International Workshop is part of 8 transnational workshops** (5 in person and 3 online) focusing on upskilling Social Economy Enabling Organisations in terms of understanding and being able to deliver Digital and Data-Driven Programs.

Participants are encouraged to engage in the project's complete learning journey, by attending all the different workshops organised within the project. Conditions and requirements for participation are presented below.

In order to be eligible, applicants must be a **Social Economy Enabling Organisation**, defined as a sectoral federation or Association representing social economy entities, providing support services to social economy entities or federate social entities.

Each applicant must be:

- a legal entity;
- established in one of the eligible countries:
  - EU Member States (including overseas countries and territories - OCTs),
  - Iceland, Norway, Liechtenstein, Albania, Bosnia and Herzegovina, Kosovo, North Macedonia, Serbia, Türkiye, Moldova and Ukraine.
